Standard Commercial Warranty: All products provided under this proposal are warranted to be free from defects in material and workmanship for the following stated warranty period from the date of delivery:

Nonin 8500 series, 9840 series, 2500 series carry a three (3) year warranty. If warranty service is required on a Nonin Pulse Oximeter, FedMedical, Inc. will provide a loaner product at no charge to the customer. Loaner provisions are based on estimated repair or replacement turn around times. Nonin Onyx series pulse Oximeters (9550, 9550-Mil sold to Government customers will be extended an seven (7) year warranty against defects. No loaner units are available for these models. Nonin sensors and patient cables interface with white or gray cables have a 90-day warranty. Nonin repair time frame averages 2 business days. Items are shipped back via UPS Orange (3 days or less).

All preventative maintenance is covered in the item direction manuals.

Fedmedical, Inc reserves the right to repair a defective unit before a replacement is issued.
